**AGREED ORDER GRANTING EMERGENCY MOTION FOR
APPROVAL OF CONOCOPHILLIPS COMPANY
CUSTOMER STATUS UPDATE FORMS**

This matter comes before the Court upon Debtors' Emergency Motion for Approval of ConocoPhillips Company Customer Status Update Forms (the "Motion"). The Court, having reviewed the Motion, heard the statements of counsel at the "first day" hearing on February 11, 2009 and fully understanding the exigencies of the circumstances under which Debtors considered the issue, the evidence, the arguments of counsel and for good cause shown,

HEREBY ORDERS THAT:

1. The Motion is granted in its entirety.

2. Given the exigencies of the circumstances under which the Motion was filed, this Court finds that notice was proper pursuant to Federal Rule of Bankruptcy Procedure 2002 and Standing Order No. 1.

3. Debtor Crescent Oil Company, Inc. is hereby authorized to enter in the CSUs¹ with the Interim Suppliers. The Interim Suppliers shall supply the ConocoPhillips-branded Products on an interim basis to certain of the Managed Dealers under the terms and conditions of a temporary wholesale supply agreement entered into or to be entered into between Interim Supplier and each Managed Dealer, pursuant to the CSUs.

4. With respect to each CSU, this Order shall be effective *nunc pro tunc* as of the effective date of such CSU.
