HEREBY ORDERS THAT:

1. The Motion is granted in its entirety.

2. Given the exigencies of the circumstances under which the Motion was filed, this Court finds that notice was proper pursuant to Federal Rule of Bankruptcy Procedure 2002 and Standing Order No. 1.

3. Debtor Crescent Oil Company, Inc. (“Crescent Oil”) is hereby authorized to reject the Aviation Agreement¹ effective as of February 8, 2009. Cononco Phillips Company reserves the right to assert any and all claims arising as a result of such rejection.

4. Crescent Oil is hereby authorized to reject the Airport Agreements effective as of February 8, 2009. The Airports reserve the right to assert any and all claims arising as a result of such rejection.

5. The 10 day stay pursuant to Federal Rule of Bankruptcy Procedure 6004(g) is hereby waived.
