### **Yatzaret Aguirre-Sanchez (Nashville)**

A 1L at Belmont University College of Law, Yatzaret is a member of the university's American Inn of Court and Women's Legal Society. During previous internships, she researched matters related to immigration law and estate planning and assisted with projects for decriminalizing poverty, improving school districts, and LGBTQIA+ rights matters, among other case preparation responsibilities. An active member of her broader legal community, Yatzaret is proficient in Spanish and is a member of the Latino Law Student Association, Tennessee Bar Association, and Expungement Clinic with Davidson County. She completed her undergraduate degree in political science and philosophy at the University of Florida.

### **Kaylen Aldridge (Denver)**

Kaylen is a Student Bar Association elections commissioner and a student ambassador at the University of Colorado Law School, where she is currently a 1L. She is also an active member of the Women's Law Caucus, treasurer of the Society for Work, Employment, and Labor Law, and participated in the Interdisciplinary Ethics Tech Competition. Kaylen completed her undergraduate degree *summa cum laude* with a triple major in business administration, business management-human resources, and political science at the University of Arkansas.
