Overview

His primary focus is on medical malpractice prevention as well as defense, and he often conducts in-service programs for his clients as well as grand rounds programs for hospital physicians.

Brian devotes a good portion of his practice to defense of Utah hospitals, hospital systems, and university medical facilities and providers. He assists these clients with a range of medical malpractice matters and issues relating to quality improvement and risk management.

In addition, Brian represents medical doctors and other health care providers who are insured by medical malpractice insurance providers. His clients in this area include the University of Utah, Podiatry Insurance Company of America, and Mutual Insurance Company of Arizona. As a variation in his practice, Brian also represents Utah's largest amusement park.
