Overview

J.T. In addition to his service to local government as bond counsel, he has served as underwriter’s counsel to local and regional investment firms.

Maintaining broad reach and impact throughout the public sector, J.T. also serves as general counsel to KPP Energy, a nonprofit, member-owned municipal energy agency providing electricity to 24 Kansas communities; and as city attorney to Andover, Hesston, and Mulvane, Kansas.
