Complex Fraud Matters

- Represented a Chapter 11 trustee pursuing numerous insiders and third parties for participation in debtors' Ponzi scheme resulting in \$140 million loss, fraudulent conveyance claims, and other matters. Realized settlements that resulted in approximately 70% recovery for creditors on an initially insolvent estate.
- Represented a client in matters arising from Fyre Festival collapse and resulting fraud claims.
