- Currently pursuing environmental contribution, breach of contract, indemnification, and additional common law claims on behalf of Bayer US LLC in a pending multi-party consolidated lawsuit in Nebraska federal court against owners and operators of a mismanaged ethanol plant that improperly disposed of solid waste byproducts.
- Currently serving as co-counsel in multi-party effort to remediate former Nebraska ethanol plant under the state's voluntary compliance program.
- Currently defending energy producers against CERCLA successor liability contribution claims in the Southern District of Illinois.
- Defended against a pending private party CERCLA contribution lawsuit against multiple potentially responsible parties in the Southern District of Ohio.
- Successfully defended clients facing CERCLA / RCRA / CWA governmental, private party and citizen suit claims in multiple jurisdictions across the U.S. involving alleged hazardous and solid waste contamination at landfills, recycling facilities, manufacturing facilities, and electrical transformer repair facilities.

- Obtained dismissal of a New Jersey Spill Act lawsuit on jurisdictional grounds, leading to a low-dollar settlement that ended a decades-long CERCLA and New Jersey successor liability dispute between private parties.
- Achieved a low-dollar settlement for an aerospace client against legacy claims of successor liability stemming from the remediation of a CERCLA Superfund site adjacent to the Gary, Indiana airport.
- Won a CERCLA contribution trial judgment in the Western District of Virginia. The adjacent property owner wrongly denied CERCLA contribution liability for remediation of releases and threats of releases of hazardous substances from legacy lead and zinc mine-tailing disposals on the client's property. Stopped the state's decades-long erroneous assertion of regulatory authority under the Clean Water Act over her client.
- On appeal to the U.S. Eighth Circuit Court of Appeals, Jane argued for and won the right for non-settling potentially responsible parties (PRPs) to intervene to challenge entry of a CERCLA consent decree between the U.S. The EPA / DOJ and settling PRPs concerning the cleanup of a PCB-contaminated former transformer repair and sales facility in Cape Girardeau, Missouri. This was the first federal appellate decision to recognize a right of PRPs to intervene.
- Obtained a temporary restraining order in Illinois Circuit Court prohibiting an Alabama attorney from soliciting personal injury clients in southern Illinois in violation of the prohibition against the unauthorized practice of law and forcing removal of his "Toxic Waste Lawsuit" billboard advertisement.
- Experienced conducting effective expert witness examination and pretrial motion practice, used to limit and often eliminate scope of environmental, tort, property damage, and nuisance claims facing clients.
- Experienced defending against putative class action certifications including a case in the Central District of Illinois involving alleged harmful air emissions from a large fire and explosion at a manganese plant in southern Illinois.
- Collaborated on strategy, discovery, and briefing pre-trial motions in a 300-plus plaintiff action alleging property damage and emotional distress associated with mercury emissions from a Chloralkaline plant in Alabama.
