## Overview

Throughout her career, Jessica has worked with clients to monitor the ongoing changes in chemical regulations and implement programs to manage evolving state, local, and federal requirements for chemical management, disclosure, and research.

- Represented participant in multiparty Superfund site during negotiations of remedy change with EPA Region VII and MDNR, including National Remedy Review Board review process. This included coordination with private and public co-PRPs and management of substantial public interest in remedial selection process.
