Overview

Josh acts as regional and national counsel for several debt collection agencies and law firms. He has previously served as the Nebraska State Compliance Chair for the Association of Credit and Collection Professionals (ACA) International, and on the ACA's Council of Delegates. Josh is a regular speaker / contributor on FDCPA compliance and litigation issues.
