

- Serves as outside counsel for manufacturer regarding its warranty programs, shifting of risk on tariffs, and compliance with changing sanctions regimes.
- Successfully represented board of directors throughout sale of \$200 million real estate portfolio, effectively assisted with partnership communications, and minimized effect of minority partner litigation claims on closing of sale.
