

### **Related Experience**

- Successfully defended a motion for summary judgment against a large insurance company in a federal securities fraud lawsuit, resulting in a \$2.2 million settlement in a case where actual damages were \$1.4 million.
- Obtained a defense verdict against Stanford University in a landlord-tenant dispute over alleged use violations in Stanford's around lease.
- Successfully defended a commercial real estate developer against allegations of fraud and breach of contract in a six-week jury trial in Shasta County. Client was awarded all attorney fees and most costs to defend the action.
