He also has a proven track record of successfully negotiating resolutions with the U.S. Environmental Protection Agency (EPA), the Arizona Department of Environmental Quality (ADEQ), the Arizona Department of Water Resources (ADWR), and guiding clients on Clean Water Act (CWA) compliance and related state statutes.

Clients benefit from his extensive experience counseling municipal, industrial, and commercial clients through the full process for development projects on public lands, as well as those on private, state, federal, and Native American lands. This includes acquisition, sale, transfer, and wheeling of surface and groundwater rights in the Southwest. He has managed environmental permitting and compliance work for utility and infrastructure projects such as solar and wind farms, power lines, and pipelines.

Many of Matthew's clients operate in the mining, utility, and agricultural sectors and in geographies with numerous water restrictions. In addition to transactional due diligence with developers, he handles the submission of comments on environmental impact statements and environmental assessments and advises on how to leverage water rights. He has guided clients through the sale of excess water to industrial users and for the generation of credits, helping to build resilience and flexibility into water storage and distribution systems.
