Overview

Related Experience

- Defended a county in consolidated appeals before the Utah State Tax Commission and succeeded in having all appeals denied, thus preserving tens of millions of dollars in tax revenue.
- Obtained favorable decisions from the Utah Antidiscrimination and Labor (UALD) and EEOC in proceedings against employer in case where employee was accused of rampant sexual harassment, discrimination, and retaliation.
- Reached positive resolution of land use dispute in which property owners challenged permits provided to neighboring residential rehabilitation facility.
- Prevailed on a motion for summary judgment in federal court, obtaining complete dismissal of claims against corporate client for employee's death in accident caused by a third party. Decision was affirmed on appeal to the Tenth Circuit.
