Related Experience

- Defended a manufacturer in a high-stakes, 14-day patent infringement trial, securing a complete victory that included findings of non-infringement, patent invalidity, and inequitable conduct by the plaintiff. A multimillion-dollar counterclaim verdict was awarded, holding the plaintiff liable for tortious interference with the client's business. Additionally, a subsequent lawsuit piercing the corporate veil ensured full collection of the judgment.
- Led a five-day jury trial on behalf of an international manufacturer and distributor based in Singapore, defeating allegations of breach of contract and breach of warranty.
- Prevailed in a seven-day jury trial for a nationwide catalog and television marketing corporation, defeating claims of fraud, breach of contract, breach of fiduciary duty, conspiracy, and corporate dissolution.
- Served as lead trial counsel in a three-day arbitration before the American Arbitration Association (AAA), obtaining a favorable outcome for a software development company in a case involving breach of contract and copyright infringement.
- Secured a multimillion-dollar judgment in a case of financial fraud and breach of fiduciary duty, saving a closely held family business that had thrived for over four decades but was nearly dismantled by a CEO who diverted millions to a competing venture.
