Overview

Pat's experience includes cases involving allegations of business disputes, health care and tax fraud, commercial merchandising practices act violations, criminal trade secret violations, and general criminal violations and civil disputes. He provides representation to people and companies in the private and public sectors, in matters ranging from high stakes civil and criminal litigation to government proceedings and internal investigations.

Pat is retained by clients to design and execute internal and parallel investigations, develop crisis response protocols, and to coordinate defense tactics and strategy.
