Overview

- Lead counsel in defending multiple hybrid class/collective actions in 2022-2024 alleging overtime violations for candy manufacturer, including court-approved settlement of collective involving over 1,000 workers employed by manufacturer and seven temporary staffing agencies.
- Successfully secured \$1.75 million settlement involving approximately 350 opt-in plaintiffs in 2024 in vigorously litigated FLSA collective action brought against federal contractor and subcontractors providing kitchen and catering services for temporary refugee camps.
