## **Related Experience**

- Successful prosecution of 150+ commercial receiverships for bank clients, including evidentiary hearings and trials.
- Successful prosecution and defense of a wide range of expedited injunctive relief and other evidentiary and trial proceedings for banks, employers and owners of real estate in cases ranging in value from \$5,000,000 to \$60,000,000.
