## Overview

Since graduating law school in 1997, Stephen has dedicated his career to helping clients resolve and avoid complex business disputes and contractual disputes, as well as those involving copyrights, trademarks, patents, antitrust, rights of publicity, trade secrets, noncompete violations, defamation, and domain disputes. He has defended clients in MDLs (multidistrict litigation), and represented both plaintiffs and defendants in class actions. His clients hail from technology, software, health care, real estate development, entertainment, architecture, design, music, film, and other creative fields, and range from startups to household names. He also advises his clients on emerging issues in AI and the intersection between law and technology.

Stephen represents clients in courts and arbitral forums across the country, and he is routinely called on to serve as local counsel within Tennessee's state and federal courts. He also serves as outside general counsel to multiple companies. Upon graduating from law school, Stephen served as a judicial clerk to the Honorable Thomas A. He is a frequent speaker and author on issues in business litigation, IP litigation, and litigating before the Tennessee Business Court. He co-authored "The Pro-IP Act: Another Weapon Against a Failing Economy," published by the ABA's *Landslide* magazine, as well as "Race is On to Recapture Copyrights," published by *The Tennessean*, and co-authored an article published by *Law360*. Fellow attorneys routinely recognize him as one of the "Best of the Bar" within Nashville and the Southeast in peer-review rankings.
