Overview

- Successfully defended the Kansas Department of Health and Environment / Division of Health Care Finance and a managed care organization in the dismissal of a provider's Medicaid benefit recovery claims; administrative ruling affirmed on appeal.
- Obtained summary judgment on behalf of a school district where the plaintiff alleged premises liability; judgment affirmed on appeal.
- Obtained summary judgment on behalf of a school district and a building administrator where the plaintiff alleged bullying, discrimination, and retaliation claims.
- Obtained several summary judgments on behalf of plan providers in ERISA actions alleging benefit denial claims.
