Areas of Focus

Adoption and Guardianship

Guiding clients through the legal and bureaucratic process of obtaining adoptions and guardianships. The Spencer Fane Family Law team has advised families on both traditional and nontraditional adoptions. We help clients navigate the often lengthy and complex adoption process, providing legal representation for adopting parents and stepparents.

In some states, before assigning guardianship, a court must first determine whether both of the child(ren)'s parents are deceased, circumstance or court order have severed both of the parental relationships, both parents have consented to the guardianship, or a combination of those factors exists. A guardianship can be temporary or permanent, and the court will always look to the best interests of the minor child(ren).

Asset Division and Spousal Maintenance

Dividing assets equitably, determining the appropriateness of spousal maintenance (alimony). When substantial assets are involved, divorces become more complex. In most states, marital assets are to be divided equitably, although not always equally. Spencer Fane attorneys assist clients in identifying, characterizing, valuing, and asserting ownership of marital and separate property.

Spousal maintenance is the term used to define the financial assistance one spouse of a divorcing couple may be required to pay to the other. If a spouse is eligible for spousal maintenance, the court looks to a list of enumerated factors to determine the amount and duration. Spencer Fane assists clients in determining if an award of spousal support is appropriate under their specific circumstances.

Child Custody and Support

Developing a child custody arrangement that will be beneficial to your newly defined family. Spencer Fane ensures that the needs of the child(ren) in divorcing families, or those involved in other family disputes, are a priority. Our focus on the best interests of the child(ren), in any legal situation, is unyielding.

Our Family Law attorneys assist clients with:

- **Child custody, including both physical custody and legal custody.** Physical custody refers to where the child(ren) will primarily live. Legal custody refers to the decision-making authority of one or both parents.
- **Child support,** meaning financial support of children as deemed necessary and appropriate by state law. Generally, support payments are based on combined parental income and the parenting-time schedule shared by both parents.
- **A state's child support guidelines,** including how the process of receiving or paying child support works.
- **Modifications or enforcement of child support orders** after a divorce is final in the event there is a substantial and continuing change in circumstances of either party.

Collaborative Divorce

Avoiding a protracted, expensive, and traumatic divorce proceeding. Collaborative divorce addresses each dimension of a divorce – legal, financial, and emotional – with the objective of avoiding the length, expense, and emotional trauma of a traditional divorce.

A collaborative divorce involves an attorney and a divorce coach for each party, a financial specialist, and a child specialist, and it puts families first by allowing couples to maintain control over their decisions, resolving differences without the threat of going to court.

- **Facilitate a transparent process** by cooperating fully with disclosure and discovery requests and enabling both participants to make informed decisions.
- **Foster a private and dignified proceeding**, guiding couples through a divorce and preparing them for the future.
- **Lay the groundwork for a family to move amicably from one household to two**, treating the transition with reverence and respect while keeping the needs of the family and child(ren) at the forefront of the process.

Complex Family Litigation
